Report on the e-voting conducted at the 30th the Annual General Meeting ("AGM") of NCC Limited, ("Company") held through Video Conference or Other Audio Visual Means held on Friday the 25th September 2020, at 3.00 P.M IST

- As per the provisions of the Section 108 of the Companies Act, 2013 ("Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided facility for voting through electronic means ("remote e-voting") and Instapoll facility for the meeting on all the Resolution(s) contained in the Notice of the AGM.
- I, A. Ravi Shankar, Practicing Company Secretary, resident of Hyderabad was appointed as the Scrutinizer to scrutinize the votes casted through remote evoting as well as Instapoll by the Shareholders of the Company to ascertain results for the Resolutions contained in the Notice of the AGM.

Kfin had set up electronic voting facility on its website: <u>https://evoting.karvy.com</u> on all items of business (both Ordinary and Special) sought to be transacted at the AGM. As mentioned in the Notice, the remote e-voting facility for voting was made available to the Share hoders during the period Tuesday the 22nd September, 2020 (9.00 a.m. IST) to Thursday the 24th September, 2020 (5.00 p.m. IST)
- After conclusion of meeting, the votes cast through Remote e-Voting facility were duly unblocked by me as a Scrutinizer in the presence of two witnesses who are not in the employment of the Company.
